Can I complete Chartered Manager if I do not have a management qualification?

If you are an experienced manager with 5 or more years' experience you can be assessed jointly for Membership and Chartered Manager. You will need to complete a combined Membership & Chartered Manager application form, plus the requirements of the Chartered Manager assessment process.

How long will it take me to complete Chartered Manager?

Through an on-site visit from one of our Advisor, who will assess your claim for Chartered Manager, review your supporting evidence on-site, and write up submission documents based on your discussion. Through this route the award can be achieved in as little as 2-3 months (with a time commitment of 5-10 hours).
